## What is the 21st Century Club?

An employee annual gift plan for endowment contributions. Endowments are a leading indicator of an institution's distinction. They provide long-term security of National University's academic and scholarship programs, ensuring that our library and other vital student resources remain state-of-the-art.

## Three Ways of Joining

### 1. Payroll Deduction

A payroll deduction is an easy way to support the National University Endowment on an ongoing basis. Simply choose from one of the contribution amounts listed, or write an amount of your choosing, and that amount will be automatically deducted from your paycheck each pay period.

### 2. One-time gift

Making a one-time gift enables you to choose a gift level that is easy to factor into your budget. Gifts can be made by check or credit card.

### 3. The Chancellor's Circle

The Chancellor's Circle is an exclusive club with the express purpose of increasing the Scholarship Endowment. Contributions will be matched by National University, doubling the value of each member's gift. Membership entails a contribution at one of the following levels:

**Chancellor's Gold Circle:**

\$10,000 pledged each year for five years

**Chancellor's Silver Circle:**

\$5,000 pledged each year for five years

**Chancellor's Bronze Circle:**

\$3,500 pledged each year for five years

## Frequently Asked Questions

### *Why should I give?*

Your participation demonstrates pride in your work and your commitment to National University. Participation from employees also enhances the ability to secure funding from foundations and other agencies.

### *Are my contributions through the 21st Century Club tax-deductible?*

Yes, all contributions are 100 percent tax-deductible. They are documented on your paycheck stub, and receipts are issued by the Office of Development and Alumni Relations.

### *Who benefits from my contribution?*

The 21st Century Club benefits everyone connected with the University—students, faculty, staff, and the communities we serve.

### *How will my contributions be recognized?*

You will receive a thank you letter from the President for your generous gift.

### *How can I make my contributions?*

Your contribution can be deducted from your paycheck, or you can make a cash gift by check or credit card.
