

1.) The Coronavirus Aid, Relief, and Economic Security (CARES) Act provides colleges and universities with higher education emergency relief related to the coronavirus pandemic. To be eligible to receive the emergency relief, institutions were required to sign and submit the Certification and Agreement. National University completed the requested Certification and Agreement in April 2020. The total amount of funds allocated to National University pursuant to the institution’s Certification and Agreement for the Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs was \$ 14,581,740

National University has received the following allocations under the HEERF/CARES act:

- April 2020 – HEERF I - \$2.28 million received from the Department pursuant to the Certification and Agreement for Emergency Financial Aid Grants to Students.
- January 2021 – HEERF II - \$2.28 million awarded from the Department pursuant to the Emergency Financial Aid Grants to Students.
- July 2021 – American Rescue Plan (ARP) – HEERF III - \$10.02 million awarded from the Department pursuant to the Emergency Financial Aid Grants to Students.

The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs through December 31, 2021 was \$10,367,198 as follows:

- 2.) National University has an estimated 23,000 students eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.
- 3.) National University has awarded \$6,094,373 in Emergency Financial Aid Grants for the quarter ended December 31, 2021, under HEERF II/III to 4,462 students under Section 18004(a)(1) of the CARES Act in the amount of \$800 (679), \$1,000 (1927), \$1,500 (3), \$1,800 (438), \$2,000 (1413), \$2,011 (1) and \$3,262 (1).
- 4.) The methodology used by the university to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs are as follows:
